

New NREMT Level

With the nationwide implementation of the new **EMS Education Standards**, the National Registry is phasing out the EMT-Intermediate-85 level and replacing it with an upgraded version called Advanced EMT.

In order to upgrade to this new level, Providers must :

Attend an approved Refresher Training Program (RTP) taught to the new **EMS Education Standards** containing the **NREMT Transition Course** content

AND

Successfully pass the NREMT Transition Exam for I-85 to AEMT

OR

Recertify by taking the NREMT Exam-in-Lieu (one attempt only)

New EMS Education Standards

Until recently, EMS Providers have been educated using the DOT National Standard Curriculum (NSC) which has not been updated since 1985. In the early 2000's, work was begun to completely revise the curricula that EMS Providers train to. This work produced the National EMS Education Standards. These new Education Standards raise the bar for the education of EMS Providers by educating them to have a deeper knowledge of a wider variety of subjects. All Nationally Registered EMS Providers will be educated to these new EMS Education Standards moving forward. Those Providers educated to the old NSC will need to take a refresher course that contains the new material, termed **Transition Course** content or demonstrate competency by passing the NREMT cognitive exam.

****“BUYER BEWARE”****

Recertification by continuing education alone brings with it a significant level of record-keeping and careful selection of courses on the part of the Provider using this method to recertify. If you are going to use ConEd for the refresher component make sure you get it from a reputable and responsible source. And be sure to maintain meticulous records of courses used.

NH EMS Providers who recertify with the National Registry by all continuing education will have their education records subject to audit by the Bureau of EMS. At a minimum the EMS provider who is audited will need to produce a written certification for each hour listed in the refresher. We may further require that the provider submit the full documentation of individual courses as noted below. If that happens, the provider will need to contact the individual who conducted that program for that information.

The Bureau of EMS needs to make sure that our providers receive quality education, so any ConEd that is intended to be used for the refresher training component of recertification will have to meet certain requirements. The individual who is conducting a continuing education program intended for use for the refresher training component must maintain the following documentation:

- A list of educational objectives for the program,
- Credentials of the Instructor demonstrating the appropriate expertise to teach the subject,
- The number of hours of the program,
- The date, time and location of the program,
- A course roster with participants' names and signatures.

Transition Method

36 hours total

Recertify with the NREMT and upgrade to the new Advanced EMT level.

36 Hour NEW Standards RTP

Take a formal, state- or CECBEMS-approved 36 hour Refresher Training Program (RTP) taught to the “NEW EMS Education Standards”.

+

Pass the NREMT Computer Based Test (CBT)

1. Create an account on the NREMT website (if necessary) by clicking “Create new account” at www.nremt.org
2. Log in to your NREMT account
3. Complete an AEMT transition application, pay \$70.00 fee (or enter voucher code)
4. Applicant submits transition application, which is then verified by NH state office
5. NREMT generates Authorization to Test letter
6. Applicant logs-on to Pearson Vue’s website to schedule test

Most NH-approved RTPs are being taught to the new EMS Education Standards and are being advertised as “EMT-Intermediate-85 to Advanced EMT RTP (EMT-I-85 to AEMT RTP Conversion)”

BE SURE TO CHECK WITH YOUR RTP INSTRUCTOR TO DETERMINE WHAT STANDARDS YOUR COURSE IS BEING TAUGHT TO.

Traditional Method

72 hours total

Recertify with the NREMT at the “old” EMT-Intermediate—85 level.

24 Hour EMT-Basic RTP

Take a formal, state- or CECBEMS-approved 24 hour Refresher Training Program (RTP) taught to the “OLD National Standard Curriculum” Standards.

+

12 hours of ALS Con-Ed

Take 12 hours of ALS continuing education.

+

36 hours of Continuing Education

Take 36 hours of Continuing Education

This method does NOT allow the EMT-Intermediate to transition to the new Advanced EMT level. The EMT-Intermediate will need to take a “new Education Standards” course with NREMT Transition/Conversion content by March 31, 2015 (odd-year expirations) OR by March 31, 2016 (even-year expirations) or the NREMT will drop the registrant down to the next-lowest registration level (EMT).

BE SURE TO CHECK WITH YOUR RTP INSTRUCTOR TO DETERMINE WHAT STANDARDS YOUR COURSE IS BEING TAUGHT TO.

Exam-in-Lieu

0 hours total

Pass the NREMT Computer Based Test (CBT)

Log onto www.NREMT.org and complete an application for recertification by examination.

Pay \$70 exam fee to NREMT

One attempt to pass otherwise Providers must refresh by one of the other methods listed.

Recertify with the NREMT and upgrade to the new Advanced EMT level.

Transition Course

The term “Transition Course” now refers to the educational components required to “transition” or “convert” to the new NREMT Levels.

The old New Hampshire term “Transition Course” or “Transition Modules” has been changed to “NH Scope of Practice Modules” to describe the educational modules required to use the NH Statewide Patient Care Protocols.

Out-of-State Refreshers

While out-of-state refreshers are now an acceptable method to recertify, Providers need to make sure that the refresher will be accepted by the NREMT and that they adhere to the new EMS Education Standards for Transition Course content if the Provider intends to transition to the new NREMT levels.

Con-Ed Only Method

72 hours total

Recertify with the NREMT at the “old” EMT-Intermediate-85 level.

36 hours of SPECIFIC Con-Ed
